## Personal data collection

When you register for either a demo trading account, or a live trading account with EZInvest, we need to collect some personal data from you for our business and record-keeping purposes. It's very important that we fully understand your financial needs, as this allows us to treat you as fairly as possible. The information we gather about you also allows us to provide you with the most suitable financial products and services, as well as give you the appropriate information on investment strategies (not financial advice), and process your requests and transactions. Finally, the data you provide, gives us a better overview of how we can assist you when it comes to both sales and post-sales services.

## What personal data do we request?

We request the following information from you:

1. **Personal and financial information.**  
This is request from you during the online (or offline) registration of a EZInvest Live Trading Account.
2. **Proof of ID.**  
After you have completed the online or offline EZInvest Live Trading Account application form, we request documents that prove your identity as well as your residency. These documents include:
  1. Internationally recognized passport
  2. National identity card
  3. Driver's license
  4. Utility bills such as an electricity, gas or phone bill (not mobile phone bill)
  5. Bank statements

### What happens if I choose to not be a client of EZInvest?

If you do choose to end your working relationship with us, we are required to keep your Personal Data on our records for five (5) years, starting at the point where you explain in writing that you no longer want to be a client of EZInvest.

### How we use your personal data

We've provided a list that pinpoints why EZInvest may need to use your personal data:

1. To verify your identity;
2. To manage your EZInvest trading account;
3. To ensure that you meet all the necessary suitability requirements needed to use our financial products and services;
4. To process any transactions you wish to make, be it moving funds from one account to another, making a deposit, or a withdrawal;
5. To send you information about your transactions;
6. To keep you fully updated with regards to our company news, product announcements, and any other information that's relevant to your working relationship with us;
7. To improve your EZInvest.com user experience; and
8. To provide you with better financial products and services in the future

### The use of cookies

We use both EZInvest developed and third-party cookies on our website, and these cookies are tiny bits of data that's stored on your web browser when you visit our website for the first time, or if you have cleared your cache and returned to our website.
